
Please refer to your letter No. F.2-1/SZABMU/ 2021-9110, dated 8th July, 2021 on the subject cited above. It is informed that as per PMC Medical and Dental Undergraduate Education (Admissions, Curriculum and Conduct) Regulations 2021- Notification (section no. 18 and 19) of migration/transfer for students from one college to another.

- a) *any student enrolled in any medical or dental college in Pakistan may transfer to another college in the same program at the same level subject to a vacant seat available in the college where the student is seeking to transfer. Such transfer would be further subject to any rules of the university to which the college where the student is seeking to transfer is affiliated with.*
- b) *any student enrolled in any foreign medical or dental college may transfer to any Pakistani college in the same program subject to having completed at least 2 years of the foreign program and having qualified the relevant NEB exam. The transfer would be further subject to a vacant seat available in the college where the student is seeking to transfer.*

It is further informed that PMC has already conveyed this decision as per our letter No. F.9-Se. PMC-2020/Transfer-Migration/006, dated 7th July, 2021 (copy enclosed).

You are requested to facilitate the students who have applied for migration as per above mentioned decision regarding migration /transfer of students from one college to another college.
